WELCOME to The Off-Road Championship Series sponsored by TRAXXAS and Presented by AMSOIL.

WEBSITE- www.TORCseries.com is now live and interactive. Please visit our site and fill out the Driver Profile at your earliest convenience.

TORC SERIES DRIVERS are required to have a USAC license to be eligible for event entry, prize money, contingency and insurance. USAC will supply licensed drivers with the mandatory suit patch, vehicle decal, rule book and identification credentials. Crew member licenses are recommended. The benefits and criteria for drivers and crew licenses are outlined in the rule book.

TEAM DRIVERS must also be USAC licensed. ONE team driver is allowed and must be named on the Driver of Record's event entry form PRIOR to the start of the race season. Points are assigned to the TEAM.

SINGLE EVENT ENTRY- If you wish to enter single race events at a later date, a Single Event Entry Form is enclosed for your convenience. Please make several photocopies and be sure to send it in two weeks prior to the race event. At-Track Entry will incur the \$35.00 late fee.

PRO RACE TEAMS- Mandatory Radio Upgrade

SRT RACE TEAMS are encouraged to purchase this radio upgrade for their spotters. USAC has developed a new one-way radio communication system required for the TORC Series launching in 2009. Race team communication systems for spotters, etc can still be used, as the USAC radio can be placed in-line between the team radio and driver earpiece inside the race vehicle. USAC Race Control communications will suppress team communications by 20% when necessary for safety conditions, or for driver line-up instructions, etc. The cost of the radios are \$129.95, and come complete with connection cables for team radios as well as driver

TIMING- TORC Series will be utilizing the Westhold Timing System, as implemented in the Midwest in 2008 for all PRO and SRT Division Classes. Transponders will be available for sale at the tracks.

ROOKIE- The Rookie programs will be instituted in 2010. In 2009 every driver is a rookie in this Series.

PLEASE provide the requested information, thoroughly complete all blanks and print clearly and return pages 2 thru 6. Entry form must be signed and initialed where indicated. Note that the **Driver of Record** is solely responsible for the accuracy and content of their entry form. It is recommended that you photocopy the entry form before submitting it to TORC Series. MasterCard, Visa and personal checks are accepted. Membership and Race Entry fees received at a Race event are subject to a \$35 late fee. Returned checks are subject to a \$25.00 processing fine.

"PARTICIPANT" HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS not to sue the Series owners, employees or subcontractors, promoters, participants, racing associations, sanctioning organizations or any subdivision thereof, track operators, track owners, officials, car owners, drivers, pit crews, rescue personnel, personnel in any restricted area, sponsors, advertisers, owners and lessees of premises used to conduct the events, premise or event inspectors, surveyors, underwriters, consultants and other persons or entities who give recommendations, directions or instructions or engage in risk evaluation or loss control activities regarding the premises or events and each of them, their directors, officers, agents and employees, (hereinafter "RELEASEES"), FROM ALL LIABILITY TO "PARTICIPANT", FOR INCLUDING BUT NOT LIMITED TO ANY AND ALL CLAIMS, DEMANDS, LOSSES, OR DAMAGES ON ACCOUNT OF OR IN PART BY INCLUDING BUT NOT LIMITED TO THE NEGLIGENCE OF THE "RELEASEES" OR OTHERWISE.

2. "PARTICIPANT" HEREBY ASSUMES FULL RESPONSIBILIY for including but not limited to any risk of bodily injury, death or property damage due including but not limited to the negligence or gross negligence of "RELEASEES" or otherwise while including but not limited to being in or upon the restricted areas and or while competing, officiating, observing or working for, or for any purpose participating in the events.
